How to Report an Injury while on patrol:

Step 1: Immediately report injury to Citrus Dispatch via radio and, if possible, advise them of your medical condition, as follows:

- Medical assistance is or is not required in your estimation.
- You are able to obtain medical assistance on your own.
- Emergency Medical Service (EMS ambulance) is needed.
- Not sure of what to do? Ask Citrus Dispatch to send EMS.

Step 2: Ask Citrus Dispatch to have a CCSO "Supervisor" respond so as to make an injury/incident report. This report is absolutely mandatory in pursuing a Worker's Comp claim!

Notify your Sergeant, or Lieutenant who will notify Sugarmill Woods Crime Watch President of the incident ASAP.

Sheriff Vicent's reorganization first step: review volunteer application. Review and/or replace Crime Watch vehicles, driver test of members.

Body worn cameras for Deputies, new sub-station in Inverness, Relocate Crystal River substation.
